ADOPTION AGREEMENT & ACKNOWLEDGMENTS

- 1. Ownership Transfer** Upon approval of the adoption and payment of the adoption fee, ownership of the dog is transferred to the Adopter, subject to the terms of this Agreement.
- 2. Lifetime Commitment** The Adopter agrees that adoption is a serious, lifelong commitment and will provide proper care, housing, training, exercise, and companionship for the dog for the duration of its life.
- 3. Veterinary Care** The Adopter agrees to provide routine and emergency veterinary care as needed, including vaccinations, parasite prevention, and prompt treatment of illness or injury.
- 4. Spay/Neuter Requirement** If the dog has not already been spayed or neutered at the time of adoption, the Adopter agrees to have the dog altered by the deadline provided by Project BP Rescue and to submit proof of completion.
- 5. Safe Housing and Containment** The Adopter agrees to keep the dog safely contained and supervised at all times. The dog will not be allowed to roam freely, be chained or tethered for extended periods, or be kept in unsafe conditions.
- 6. Indoor Living** The Adopter agrees that the dog will live primarily indoors as a family companion and will not be kept exclusively outside.
- 7. Training and Adjustment Period** The Adopter understands that rescue dogs may need time to decompress and adjust to a new environment. Project BP Rescue makes no guarantees regarding the dog's behavior, temperament, training, or adaptation period.
- 8. No Transfer to Third Parties** If at any time the Adopter can no longer keep the dog, the dog must be returned to Project BP Rescue. The Adopter may not sell, give away, abandon, surrender, or transfer the dog to any other person, rescue, shelter, or organization without written approval from Project BP Rescue.
- 9. Return Policy** If the adoption does not work out for any reason, the Adopter agrees to contact Project BP Rescue immediately and return the dog directly to Project BP Rescue.
- 10. No Breeding** The Adopter agrees that the dog will not be bred under any circumstances.
- 11. Compliance with Laws** The Adopter agrees to comply with all applicable local and state laws regarding animal ownership, including licensing and vaccination requirements.
- 12. Truthful Information** The Adopter certifies that all information provided in this application is true and complete. Any false or misleading information may result in denial of the application or reclaiming of the dog by Project BP Rescue.
- 13. Right to Deny or Reclaim** Project BP Rescue reserves the right to deny any adoption application. If Project BP Rescue determines that the dog is being neglected, abused, placed in danger, or kept in violation of this Agreement, Project BP Rescue reserves the right to reclaim the dog.
- 14. No Guarantees** The Adopter understands that although Project BP Rescue takes reasonable care in evaluating dogs prior to placement, it makes no guarantees regarding the dog's age, breed, health, temperament, training, or behavior.
- 15. Assumption of Risk** The Adopter understands that they accept the dog at their own risk. The Adopter assumes full responsibility for the dog upon adoption, including responsibility for any damage to property, injury to persons, or injury to other animals caused by the dog.
- 16. Release of Liability** The Adopter agrees that Project BP Rescue, its volunteers, representatives, and affiliates shall not be held responsible for any property damage, veterinary expenses, injury, illness, death, loss, or damages caused by the adopted dog after placement.
- 17. Indemnification** The Adopter agrees to indemnify, defend, and hold harmless Project BP Rescue, its volunteers, representatives, and affiliates from any and all claims, damages, costs, expenses, or liability arising from the adoption, ownership, or actions of the dog.
- 18. Follow-Up Contact** The Adopter agrees to provide updates, photos, and information about the dog if requested by Project BP Rescue, especially during the initial adjustment period.

19. Entire Agreement This Agreement constitutes the entire agreement between the parties and applies to the adoption of this dog through Project BP Rescue.
